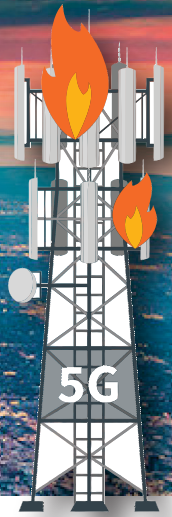

Wireless will NOT solve the Digital Divide!

There are two types of broadband connections: wired and wireless, and the best kind of wired broadband is fiber optic. Compared to fiber optic, wireless is slow, expensive, unreliable, easier to hack, prone to fires, not able to handle future speed requirements, and not yet proven safe.

The L.A. County Board of Supervisors is considering changes to the County Code that would fast-track wireless broadband. These changes would remove public notice, setbacks, oversight, safety and environmental review, and any opportunities for appeal.

This will benefit the multi-billion dollar telecom industry, and remove protections for L.A. County citizens and communities.

Fiber First LA has submitted a "Red-lined" Draft Legislation for Titles 16 and 22 of the L.A. County Ordinance. This draft submission is written to incorporate safety protections within Titles 16 & 22 for L.A. County.
